## GIVING CHILDREN HOPE

**I**mpact Ministries is working in Guatemala focusing on the Qeqchi and Poqomchi tribal people. In the rural areas around Tactic, more than 80% of the people are illiterate and this debilitates and isolates them from the 'outside' world. Impact Ministries' primary goal is to open up the Word of God to these precious people through education in Christian schools.



**T**he people of Tactic are very, very poor. The average man in Tactic earns a wage of 25 Quetzales (\$3.50 Canadian) for an 8 hour day of heavy field labour, dairy work or cutting and collecting firewood. Most families have more than five children and approximately 40% of these children are living in homes with only one parent.

**M**any parents don't understand the value of education and prefer to put their children to work, to help earn money to sustain the family. When children come to our schools, many have never held a pencil or crayon in their hand. Guatemala has seen a revival that has brought 40% of the people into evangelical Christianity. Tactic, on the other hand, has been dominated by a religion that combines Roman Catholicism, ancient Mayan traditions and witchcraft. This oppressive religious spirit has kept them in fear, bondage and ignorance. Impact Ministries is committed to loving, serving and discipling the people of Tactic.



## WHAT DOES IMPACT MINISTRIES DO?

**W**e take children that normally would have no opportunity to receive training and education, raise them to be strong leaders in the kingdom of God and help them find the place that God has prepared for them to serve Him and His people.

**W**e provide different levels of care to children. Our staff consists of missionaries and Christian national workers that provide a godly role model for the children. In all our ministries we present Jesus to the children and disciple them in their Christian walk.

### WHAT IS A CHILD SPONSOR?

A child sponsor is a person or organization who contributes \$34 or more per month to help take care of a child.

### WHAT WILL BE THE RELATIONSHIP BETWEEN THE SPONSOR AND THE CHILD?

**Y**ou will receive a photo and a history of your child in a packet explaining the sponsorship program. You may correspond with your child. The child will write to you about three times a year and you will receive a teacher report at the end of each year.



### WHAT ARE THE DISTINCTIVES OF THE IMPACT MINISTRIES SPONSORSHIP PROGRAM

**W**e are personally involved in each child's life on a daily basis and know them and their family well. Our top priority is to help each child to know the Lord Jesus and to become all that He intends for them to be.

We provide opportunities for many of our young students to earn an income. They are involved in classroom aid, school maintenance, work projects, etc. Often, our school graduates become teachers and disciple children in the same manner they
